Ease of Doing Business (EoDB)

- Jan Vishwas (Amendment of Provisions) Bill passed in Lok Sabha; Proposes to decriminalize 183 provisions in 42 legislations including over half a dozen colonial era laws to make doing business easier
- **79 positions jump in rank over 5 years**, in World Bank's EoDB ranking; **among top 5 economies** for ease of starting new business
- **300+ reforms across 72 action points** for state governments to develop investor friendly ecosystem introduced under Business Reform Action Plan (BRAP)
- 40,000 compliances reduced to improve industrial ecosystem

National Single Window System (NSWS)

- One-stop digital platform for all investor approvals, Centre & State
- Offers **GIS-enabled repository** of industrial-grade land available for investors

Indians earning over USD 12,200 per year **quadrupled in 6 years** from 2.3 Mn in 2015-16 to almost 8.1 Mn in 2021-22



Corporate taxpayers increased by **33% in 6 years** (from FY 14-15 to FY 20-21) Personal taxpayers increased by **57% in 6 years** (from FY 14-15 to FY 20-21)



Corporate tax collection increased by ~66% in 7 years (from FY 14-15 to FY 21-22) Personal income tax collection increased by ~160% in 7 years (from FY 14-15 to FY 21-22)
